Dear Governor Gavin Newsom:

As representatives of the California small business community, we write to ask you to preserve commonsense protections for small business owners shopping for capital by signing SB 33 (Glazer). We applaud California's leadership to pass SB 1235, the nation's first of its kind truth-in-lending legislation for small business owners. And we applaud the Legislature for unanimously passing SB 33, which preserves a cornerstone of SB 1235 by requiring APR disclosure for all commercial financing products. These protections were set to expire in 2024, but SB 33 will eliminate the sunset date and guarantee continued transparency for businesses.

SB 33 empowers small business owners like us to make informed decisions by ensuring we can make apples-to-apples comparison of pricing and terms. What's more, polling by Small Business Majority found that 8 in 10 small business owners are in favor of regulating online lenders to ensure interest rates and fees are clearly disclosed to borrowers.

Continuing to require these disclosures is important because small business owners, especially those of us from BIPOC communities, have little access to traditional bank loans. Plus, we are experts in our businesses, not in complex financial and accounting practices. Moreover, many financing companies share terms that are not clearly written or proposed to the borrower in a timely manner. An incomplete understanding of the product can lead small business owners to borrow more than they can afford to repay or trap them in cycles of high-cost debt. An inappropriate financing product can lead a small business to business closure and financial ruin.

SB 33 secures the future of the commonsense and now time-tested policy of APR disclosure in California. We ask for your support by signing SB 33 (Glazer) and we thank you for your leadership on this issue.
