Methodology

This opinion poll, conducted by Chesapeake Beach Consulting for Small Business Majority, reflects the opinions of 100 small business owners from Georgia. The poll, conducted from September 13 through September 20, 2022, has a margin of error of +/-10% at a 95% confidence interval. Poll respondents identified with the following political parties: 41% Democrat, 30% Republican and 23% Independent.

Clean Slate is a policy model that automatically seals qualifying criminal records if a person stays crime-free for a set period of time. As a result, background checks will no longer show this information, as eligible criminal records are sealed, expunged, erased, or set aside meaning there is no public record of the conviction. Millions of Americans with old criminal records are entitled to record sealing or expungements.

Thirty-three (33) states and the District of Columbia suspend or revoke driver's licenses for unpaid traffic or court-related fines and fees, impacting an employer's ability to hire a ready workforce and for that workforce to reliably attend work.
